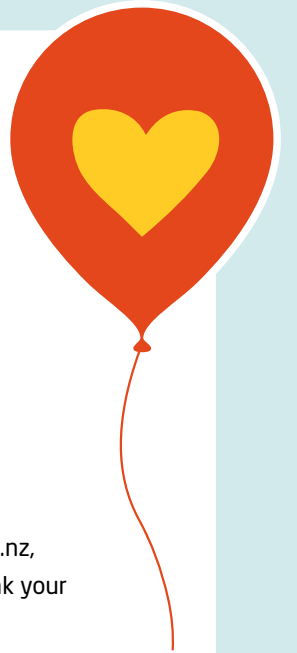

Have fun with this. Does everyone put a flower in their pocket? Re-design their uniform for a day? You choose the theme for a coin donation.

Down the line

Sponsor the boss to work in a role 'down the line'. This can produce some surprising results for everyone.

Goal for a Goal

Host a 'beat the goalie' competition. Pay to play.

The rise of the cake bake

Sell donated goods from a stall. And it's not just for the cakes... books, home-made jam, bric-a-brac and fairtrade goods can all rise to the occasion.



Brain Jars

Did you know that people who swear survive putting their hand in an ice bucket the longest? So maybe there are some benefits to swearing from a stress perspective... but make them pay with a swear jar.

The brain likes to be asked how, and it doesn't cope well with the word can't. So a can't jar has some obvious benefits. You will be surprised how often we use the word...

Board at work?

If your company has a Board, invite Board Members into the workplace for a meet and greet. Talk to them about the fundraising you are doing for the EIC - they will have some great suggestions for you.



A 'What's for' lunch

Where food comes from and what we do with it is a source of never-ending fascination. You will be surprised what's on offer when your culinary colleagues are engaged. And even better that it's for a good cause.

Organising my own event

When

Time is our best friend and our worst adversary, so choose a time that stays away from public holidays, local events and high profile sporting event dates - attendance would be pretty thin if there were a derby match happening around the corner!

Check out major event calendars on the BBC website or your local Council and Government sites.

Choose a time close to pay day for your workplace!

Where

Charities often receive reduced or free venue hire. If you are not sure how big/small the event will be look for somewhere that is flexible about changes close to the day of the event. Halls, pubs, hotels, outdoor spaces (be mindful of weather and council permissions), your workplace, someone's home - there are so many options once you start looking for them!

Keep in mind access via public transport and safety, whether you need a child friendly environment and how much noise you will make/or if you need a quiet environment.

Enjoy putting it all into action!

The Plan

Keep people informed of your plans and spread the workload.

- Divide up jobs.
- Allocate budgets

Seek donations of items and services for running your event and raffle/door prizes. Get local businesses and suppliers involved.

Balance out costs

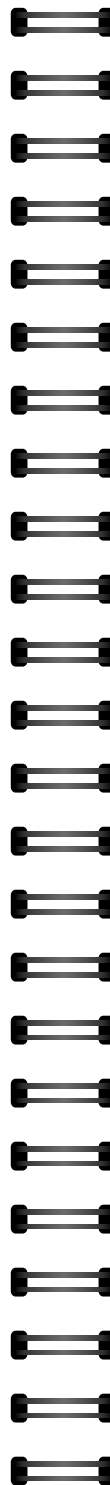
As a rough guide do not spend more than £1 for every £4 raised. Get in touch if you'd like advice before committing to any costs - we're here to help!

Easy ways to increase your funds

Ask your employer if they have a charity matched-giving scheme. They could make a big difference to your total by matching some of the money you raise, especially if you're holding your event at work.

We can claim Gift Aid on much of funds raised by our volunteers. For every £1 we can claim an extra 25p back from HM Revenue and Customs - at no extra cost to the donor! See our website for further details on Gift Aid.

People

A great event without people is just not possible. So get out early, promoting your event or activity to as many people as possible. Have tickets and sponsorship forms ready to go.

Promoting your event

Develop a media release and also use it to inform everyone you can think of. The organisation you work for, schools, community groups, churches, hotels, coffee shops and local businesses will often give you space in their newsletters or let you display a poster.

Help those who help you

Provide local suppliers with free publicity in return for their assistance

Colour your event

Enjoy decorating your event space and take lots of photos. These are great for post-event publicity and media stories. When taking photographs ensure attendees are informed and give their consent. This is particularly the case if you are taking photos of children

Ask individuals or your IT guru to add the links to your fundraising activity to as many peoples' email signature as possible.

Websites & social media

A website is a low cost/high impact way to promote your event or challenge to more people. You can create your own website (with online fundraising built-in) for free and collect money from all corners of the globe.

It also means that we can claim Gift Aid, an easy way to make 25% more on your hard-earned fundraising money.

Managing Cash

Often entry fees to events or sponsorships of challenges are paid in cash. Keep good records (including expenses if you are organising the event and paying out money). You can send the proceeds to us using either of these options:

- Bank the money and send a cheque to the EIC with your name and details of your event or challenge.
- Use our payment slips and lodge the money directly into the EIC's account.

EIC shopping list

Even a small change makes a big difference



£1 buys you a powerLottery ticket. In a calendar year, our Lottery funds over £400,000 in vital services!!!



£5 Could provide vital transport to a job interview.



£20 Could provide essential clothing for work or in the home.



£50 Could feed a whole family in distress for a week.



£60 Could help provide someone to find a new role of a lifetime within our industry.



£100 Could help provide warmth for someone who cannot pay their bills. Ill health is often behind the inability to cover life's basic expenses.



£200 Could supply an apprentice who is caring for a family member and under financial pressure, with the tools they need to keep them in their work placement.



£500 Could pay for a much needed respite break to families caring for relatives who need assistance. This helps carers to avoid the risk of mental and physical health breakdowns under their pressure of care.



£1000 Could help to get a person mobile, which is essential for a child, worker or retiree who has been born with or contracted a disease or disability that stops them from getting around.

Need to know

FUNDRAISE LEGALLY AND RESPONSIBLY

Volunteer Charter

You are part of the EIC team when fundraising on our behalf, please follow the below guidelines that help make being a team player enjoyable and fulfilling.

- > Be respectful and courteous
- > Observe health and safety, equal opportunities and confidentiality regulations and standards
- > Make sure the right licences and insurances are in place
- > Contact us with any complaints, we are here to assist!

Safety and Legal

While your support for EIC is greatly appreciated, it's important for us to remind you that Electrical Industries Charity cannot accept liability for any loss, damage or injury as a result of activities undertaken whilst fundraising for us. To ensure everything is kept legal and safe we've prepared a checklist for you. If you have any questions, or are unsure about something, please don't hesitate to get in touch - we'd hate to have all your hard work ruined over a technicality!

Health and Safety

Are you expecting a lot of people?

If so, it's a good idea to inform your local authority. If a large number of people will be driving to the event, you should inform the police.

Do you need first aid cover?

St John's Ambulance and the Red Cross can provide first aid for a small charge, but you need to book in advance.

Do you need insurance?

EIC's insurance may provide cover for some events, so please get in touch for details.

Do you need a risk assessment?

Most events, especially those held outdoors, will require a risk assessment. Contact us for advice and templates.

If using a venue, check what type of public liability insurance the owner/operator of the venue has, and ensure that it covers their liability risks.

Ensure that there is wheelchair access. And that first aid provision, emergency evacuation procedures and fire-fighting equipment are in place.

Don't let a stomach bug ruin your event!

Regulations

ALCOHOL

If you plan to serve alcohol at your public event please first check that the venue is licensed then, if necessary, contact your local authority to find out how you can obtain a temporary licence.

RAFFLES AND LOTTERIES

Please visit www.gamblingcommission.gov.uk to check whether your raffle requires a licence or not.

ENTERTAINMENT

Please contact us to check whether your event will require a Public Entertainment Licence.

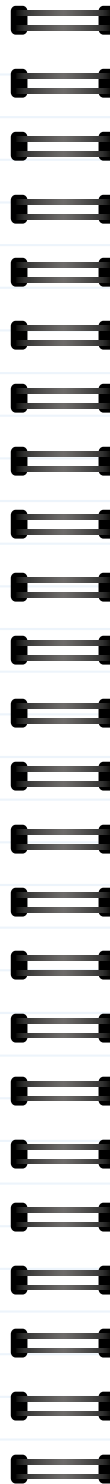
COLLECTIONS

Whilst you're more than welcome to get your family involved, it's important to remember that anyone under the age of 16 must be accompanied by an adult when collecting from the public. You must also obtain a licence from your local authority before carrying out a collection on the street or in any other public place.

GUIDELINES

For participation by under 16's: If you are under 16, we will need a parent's permission before you can take part in a fundraising event for us.

Practical Participation Programme (PPP)

Max Parker, York

The Electrical Industries Charity is undertaking a build project to help a family in need with their new Practical Participation Programme (PPP).

At six years of age Max Parker cannot see or communicate, he is wheelchair bound and unable to do anything for himself. Son to Mark and Lisa and brother to Lily and Ben, Max was born 26 weeks' gestation and was diagnosed with Quadriplegic Cerebral Palsy, Dystonia and Chronic Lung Disease. Max and his family live at home in York, which is not fitted for someone who is severely disabled. As Mark and Lisa have been lifting Max everywhere for the last 6 years, this is not sustainable and have been granted a Disabled Facilities Grant of £30k for a full two storey extension to their home to enable a through floor lift to be built which will transport Max up to his bedroom and wet room. However, the total cost of the adaptation works including the council fees, is over £80K. After extending their mortgage, using their life savings, sourcing additional loans and reaching out to other charities, Mark and Lisa are still left with a shortfall of £26K which the Electrical Industries Charity have agreed to meet due to Mark having served 18 years in the electrical industry. Our Practical Participation Programme is set up to harness specialists skills in terms of

time, equipment and materials towards providing practical help where it is needed most. In order for us to help the Parkers modify their house to assist with Max's disability needs we need practical assistance in regards to voluntary services or donated materials to drastically reduce the cost of the project. If you are interested in helping the Parkers today, please read below for how you can help.

In phase one of the project our industry supporters donated all the lighting (supplied by Collingwood lighting), the underfloor heating (supplied by Heat Mat) and all the electrical products (supplied by Edmundson Data Centre York). Lisa explained to us "there are so many ways to say thank you, but none of them will express how we really feel, as a mum I felt so helpless, having the electrical equipment Edmundson's have supplied for Max is fantastic. You will never know or understand how much this means to us and you have suddenly made our lives a whole lot easier and for that we are truly grateful. We thank you from the bottom of our hearts."
